Greetings Neighbors and Business Owners,

Winter is upon us, even though the grass is brown and we have been enjoying unseasonably warm temperatures. Winter parking restrictions are in effect November 1, 2023 through April 15, 2024. This means there is no parking on any city street between the hours of 1am to 7am. In addition, on-street parking is prohibited any time three or more inches of snow has accumulated, until after the street has been completely plowed. To ensure prompt fire service and mail delivery, please keep the areas by your mailbox and around the fire hydrant clear.

Speaking of mail delivery, the city staff and some of your local officials have been receiving multiple phone calls and emails regarding no or inconsistent mail service. The USPS is a Federal Government entity, and the city has no control over the services they provide. I encourage you to reach out to them directly with questions or concerns. I did reach out and they shared they are short staffed. They are doing the best they can, especially at this extra busy time of year in the postal service industry. The postmaster has even been out delivering on Sundays.

At our December 18th Council meeting we approved the final levy and budget for 2024. Council and staff work hard on your behalf to maintain a reasonable and responsible budget. Also, you may have noticed that the land preparation has begun for the five Villa Homes being built off of Baker Park Road.

There are so many opportunities this time of year to celebrate the season both with your family and community. One of my favorite traditions is View Santa, sponsored by the West Hennepin Public Safety Department Reserve Officers. I have been attending this event since I was a child. I love how it brings the community together, all while helping others at the same time.

Rental Permits Required in Maple Plain Starting June 1st

Landlords in the City of Maple Plain are advised to take note of new rental licensing regulations under City Code Section 4-541, effective January 1, 2024. These changes are intended to streamline processes, enhance property compliance, and ensure the safety and well-being of residents.

KEY ACTION ITEMS FOR LANDLORDS

1. Mandatory Licensing and Inspections

- Landlords must ensure that no tenant occupies a rental dwelling unit without a valid rental license issued by the City for that unit.
- To obtain or renew a license, landlords must submit a comprehensive application and fees to the City office.

2. License Application Requirements

- Landlords must submit a fully completed license application, including:
 - a. Owner's contact information (name, address, email, and telephone).
 - b. Details of any owner's agent responsible for property management.
 - c. Legal address of the rental dwelling unit.
 - d. Number and type of dwelling units.
 - e. Additional information as requested by the Code Official.

3. Bi-annual Licensing

- All rental dwelling units must be licensed before being rented.
- Licenses will expire bi-annually on June 1 of even-numbered years.
- Landlords must submit renewal applications with fees by April 15, with inspections completed by May.

4. License Fee and Record Retention

- License fees, as per the fee schedule, must accompany applications.

5. Important Dates

- Initial rental permits must be submitted by June 1, 2024
- Initial rental permits will remain in effect until June 1, 2026.
- Bi-annual licensing renewals will begin June 1, 2026.

Landlords are urged to proactively address these requirements to ensure compliance. Applications for the upcoming licensing period ending on June 1, 2024, must be submitted in a timely manner.

2024 Presidential Nomination Primary (PNP)



March 5, 2024

The process to select major-party presidential candidates will take place at the PNP in March and will look much like it did in 2020. Instead of straw polls taken at the political caucuses, the state will hold a nomination primary election on Tuesday, March 5th. The presidential primary process ensures that more people are able to participate in the nomination process. Absentee voting for the PNP begins January 19th. Independence "Airport" Development Anticipated

In response to a number of calls received at Maple Plain City Hall, an explanation of the application and review process is provided below.

.

The City of Independence is anticipating the submittal of a concept plan review application for the subdivision of the "Airport" property on the southern border of Maple Plain. The process would likely take between 8-18 months depending on a wide array of factors that are not wholly controlled by the City of Independence. This would generally include the following:

- 1. A concept plan is prepared by the developer and submitted to the City for feedback. It is then presented to the Planning Commission and City Council providing feedback to the developer who can then determine if or how to move forward.
- 2. If the developer chooses to proceed with the project they would submit the following applications:
 - Rezoning (from AG-Agriculture to Low Density Residential)
 - Zoning Ordinance Amendment to Create Low Density Residential Zoning District
- 3. If the rezoning and zoning ordinance amendments are approved, the developer would submit the following applications:
 - Preliminary Plat
 - Site Plan Review

The City would provide feedback and the developer would likely revise plans and provide additional information.

4. A Public Hearing would be held by the Independence Planning Commission (with notification sent to **all property owners** within 350 feet of the development area.) The Commission's recommendation would be forwarded to the City Council for consideration.

Should the rezoning, ordinance amendment, site plan review, and preliminary plat be approved, the applicant would be required to submit final plat application.

- Plans will be submitted to Minnehaha Creek Watershed District.
- Final plat is reviewed at regular meetings by the Planning Commission and City Council. (No further public hearings are required.)

The following Items will be required by the City of Independence during this process:

- Wetland delineation
- Traffic Impact Analysis
- Hennepin County review and approval of road connections and intersections
- Metropolitan Council involvement pertaining to the sanitary sewer connection to the regional system
- Water system verification and approval of water system connection or development
- Stormwater plans and watershed approvals
- Park/trail plans

Help! I Think I Have a Leak!

A leak in your house can waste hundreds of gallons of water. You'll also be paying for water that you aren't even using! Here is how to find out if you have a leak at your house:

If you know you are currently not using any water, go and check the water meter. The Badger meter has a small red pinwheel on the face. If the pinwheel is moving, that indicates water is currently going through the meter and you have a leak.

Snow Management Protects Our Waters

Snowflakes bring beauty and enjoyment to our Minnesota landscape. They also bring slippery conditions. Unfortunately, the products we use to treat ice run off into our lakes, streams, wetlands, and groundwater with the melting snow. Deicers, like salt, applied to roads and sidewalks pollute our lakes and streams. Just one teaspoon of salt permanently pollutes five gallons of water. Deicers impair our waters, harm fish and other aquatic life, degrade infrastructure, damage vegetation, and even injure the paws of our pets.

Always shovel first before snow turns to ice. The more snow you remove manually, the less deicer is needed. Many times, the sun will take care of the rest. If you do use salt, treat only the high-traffic areas. It takes less than you think when treating your sidewalk. Only 1-4 pounds (1-4 coffee mugs) of salt per 1,000 square feet is recommended. Remember that deicers take time to work, especially as the temperature gets colder. Salt is ineffective when pavement temperatures are below 15 degrees, and should not be used. Other products may work at colder temperatures but have their own environmental impacts. Use all products sparingly and remember to sweep up any material remaining on the pavement once the snow and ice have cleared. Be patient and plan ahead to keep safe during winter conditions.

Milk cartons, juice cartons, juice boxes, soup, broth and wine cartons (empty and clean/rinse, and dry; caps on)



Plastics Cups & Containers

Yogurt cups, pudding and fruit cups, clear disposable cups (no straws), margarine/whipped cream tubs, cottage cheese and similar containers, clear produce, deli and take-out containers (empty and rinse; lids on)



Mail, office and school papers, magazines and catalogs, newspapers and inserts, phone books (clean; staples OK)



Metal Food and beverage cans (empty and rinse; labels OK)



Cardboard, cereal, cracker, pasta and tissue boxes, shoe, gift and electronic boxes, toothpaste and other toiletry boxes



Glass Brown, green and clear bottles and jars (empty and rinse; no lids)

2024 CITIZENS POLICE ACADEMY



West Hennepin Public Safety announces the 2024 Police Academy starting on February 15th and ending with graduation on April 4th. The Academy runs for eight Thursday nights, from 6-9 pm. The Citizens Police Academy is a FREE 24-hour block of instruction designed to give citizens knowledge about how the police department operates, policies, procedures, programs, and challenges.

The Citizens Police Academy was designed to create a better understanding of law enforcement through education. The Citizens Police Academy participants are presented with realistic, hands-on information, which will help each participant better understand the police department functions. The classroom and hands on information covers: **DWI** and **Traffic Enforcement**, **home security**, **personal security**, **use of force**, **including deadly force which includes a demonstration of the Taser Gun and FATS training (firearms simulation)**, **Hennepin County Dispatch Center**, **Court procedures including testifying before a Judge** and many other areas related to law enforcement.
